




PURPOSE AND GOALS OF THE Ms. Wheelchair America Program

The Ms. Wheelchair America Program is in no way a beauty contest. It is, instead, a competition to select the most accomplished and articulate spokesperson for other persons with disabilities in the United States. The selected representative must be able to communicate both the needs and the accomplishments of her constituency to the general public, the business community and the lawmakers. She is charged with a continuing effort to educate the public regarding the dignity, productiveness and basic value of disabled people. She assumes the responsibility for the ongoing effort to eliminate the architectural and attitudinal barriers that prevent people with disabilities from assuming their rightful place in society.

As Ms. Wheelchair America, her duties are numerous. Each year she has the opportunity to travel, visiting advocacy groups, making public appearances and conducting television, radio and print interviews in the fulfillment of her major responsibilities. These include promoting awareness of the needs of disabled persons, creating an awareness for the need to eliminate architectural and attitudinal barriers, informing the able-bodied public of the achievements of physically disabled people across the nation.

We plan and conduct a four day event to select our new Ms. Wheelchair America. The Program is more than just the judging panel and one 'winner' is named. We schedule workshop sessions where we offer interesting topics of personal enhancement for the women, whether about grooming, communication and interpersonal skill development, networking with community programs and other educational topics. We offer 'free time' to allow for information exchanges between contestants to take place. Many new friendships are started from the Program, as the women validate the fact they are not the only one to use a wheelchair and experience some of the things they share with each other. The Program offers an opportunity to enjoy three days at a luxurious hotel setting here the contestants are really treated as 'special guests'. The Program is much more than just a healthy competition...it's an opportunity to see the potential within and to challenge personal growth.

The Planning Board for Ms. Wheelchair America is made up of volunteers from many different community organizations, businesses, private citizens, and previous title holders. There are few administrative costs to the Program. All expenses for hosting the Program, travel for Ms. Wheelchair America and expenses associated with the national Ms. Wheelchair America Program must be secured through various fund-raising efforts, donations, etc. We welcome your assistance.





JUDGING CRITERIA

The Ms. Wheelchair America judging is based upon criteria established by the national committee of the Ms. Wheelchair America Program. The following excerpts were taken from official guidelines:

A. ACCOMPLISHMENTS 40%)

- 1. Personal achievements/accomplishments since onset of disability only in the following areas: *Academic *Vocational *Personal
- 2. Adjustment to disability.

B. COMMUNITY SKILLS (40%)

- 1. Ability to deal with media, peers, civic groups, etc.
- 2. Public Relations Skills.
- 3. Advocacy for persons with disabilities.
- 4. Self-confidence/motivation/initiative/creativity.

C. SELF-PERCEPTION/PROJECTION (20%)

- 1. Poise, demeanor.
- 2. Appropriate attire, personal presentation.

*Ms. Wheelchair America is not a beauty contest and this category is not taken as a license to choose the most attractive entrant. Instead, the items in this category are simply to express a desire to have a pleasing appearance capable of obtaining favorable responses from any audience before which Ms. Wheelchair America would appear.

Ms. Congeniality is chosen by the contestants for this year's pageant for her friendly and cheerful personality and her helpfulness to them during the program weekend.

BARRY E. DAVIS, JR. Columbus, Georgia Judge Coordinator

Barry is the Chief of Parole Officers in the LaGrange Parole Office. He was raised in Huntsville, Alabama and later earned his Bachelor of Science degree from Auburn University.

He is married to Judy R. Davis and they have two children, Ashlee and Barry (Trey), 14 and 13. He has served on the Columbus Mayor's Committee for Persons with Disabilities, the Board of Directors for the Senoia Athletic Association and remains active in other community activities.

KATER W. CORNWELL Charlotte, North Carolina Judge

Mr. Cornwell is a native of Chester, South Carolina and transplanted to Charlotte, North Carolina for the past 25 years. He graduated from Finley High School and spent 6 years in the U.S. Marine Corp. He served one tour in Vietnam where he was wounded in combat. He later developed a virus which rendered him a paraplegic.

Kater received many military declarations which included: National Defense Service Medal, Vietnam Service Medal W/1, Vietnam Campaign Medal with Device, Good Conduct Medal (First AWD), Purple Heart Medal, Presidential Unit Citation, Good Conduct Medal (Second AWD).

After serving in the Military, Kater attended Biscayne Southern College and Central Piedmont Community College in Charlotte, North Carolina where he majored in Business Management and Marketing. He has been employed

by Delta Airlines for 23 years, and also serves as Director of Advocacy Legislation, Southern PVA.

Kater is a recognized wheelchair athlete. He is a seven-time USA National Champion in weightlifting, seven-time National Wheelchair Gold Medal Winner, three-time World Champion. He represented the United States in 1992 Barcelona, Spain, Paralympic Games, and was the recipient of the prestigious Jefferson Award in 1985 for outstanding public service.

Kater Cornwell has been featured in magazines such as: Muscle and Fitness, Sports Illustrated, Jet Magazines, UPS Big Idea, Paraplegia News, Sports & Spokes, Vanguard, and others. He was also featured on CNN News, Headline News, ABC, TNT, TBS, and Kid's World.

Kater's motto is, "walk by faith, not by sight", and says that "you only fail when you fail to try". Kater is married and the father of three sons.



PEGGY KIRKWOOD Dallas, Texas Judge

Peggy Kirkwood has been with the United States Equal Employment Opportunity Commission since 1971. For the past 18 years, she has been a Federal Investigator in the Dallas District Office charged with the responsibility of investigating and enforcing Title VII of the Civil Rights Act and Title I of the Americans with Disabilities Act, the Equal Pay Act, and the Age Discrimination in Employment Act.


When the contract with the Boeing Company was up, it was back to Georgia and the Lockheed Corporation. Judy, her husband, and two sons liv-

DR. THOMAS J. WENTLAND

Dr. Wentland, more commonly known as "Tom," is a professor at Columbus College. He chairs the Department of Developmental Studies. Before coming to Columbus in 1979, he held professorships at the University of Mississippi and the University of Wisconsin.

Tom first played President Roosevelt in the Springer Theatre's production of *Annie* and continued as FDR as a "living history" program for school children. He has become a regular performer at the Little White House historic site and was the keynote speaker at the 49th Commemorative Program on April 12, 1994.

He is the author of a two-act, one-man (and one dog, Fala) show entitled, *The Squire of Warm Springs*, which premiered at the Roosevelt National Theatre at Roosevelt Warm Springs Institute for Rehabilitation in April, 1993. Since that time, he has been on a regional tour performing one- and two-act versions of the play. To date, Wentland has appeared as FDR nearly 200 times.
