Purpose And Goals Of The Ms. Wheelchair America Program

he Ms. Wheelchair America Program is in no way a beauty contest. It is, instead, a competition to select the most accomplished and articulate spokesperson for other persons with disabilities in the United States. The selected representative must be able to communicate both the needs and the accomplishments of her constituency to the general public, the business community and the lawmakers. She is charged with a continuing effort to educate the public regarding the dignity, productiveness and basic value of disabled people. She assumes the responsibility for the ongoing effort to eliminate the architectural and attitudinal barriers that prevent people with disabilities from assuming their rightful place in society.

As Ms. Wheelchair America, her duties are numerous. Each year she has the opportunity to travel, visiting advocacy groups, making public appearances and conducting television, radio and print interviews in the fulfillment of her major responsibilities. These include promoting awareness of the needs of disabled persons, creating an awareness for the need to eliminate architectural and attitudinal barriers and informing the able-bodied public of the achievements of physically disabled people across the nation.

We plan and conduct a four-day event to select our new Ms. Wheelchair America. The Program is more than just the judging panel and one 'winner' is named. We schedule workshop sessions where we offer interesting topics of personal enhancement for the women, whether about grooming, communication and interpersonal skill development, networking with community programs and other educational topics. We offer 'free time' to allow for information exchanges between contestants to take place. Many new friendships are started from the Program, as women validate the fact they are not the only one to use a wheelchair and experience some of the things they share with each other. The Program offers an opportunity to enjoy five days at a luxurious hotel setting - here the contestants are really treated as special guests. The Program is much more than just a healthy competition . . . it's an opportunity to see the potential within and to challenge personal growth.

The Planning Board for Ms. Wheelchair America is made up of volunteers from many different community organizations, businesses, private citizens, and previous title holders. There are few administrative costs to the Program. All expenses for hosting the Program, travel for Ms. Wheelchair America and expenses associated with the national Ms. Wheelchair America Program must be secured through various fund-raising efforts, donations, etc. We welcome your assistance.

Judging Criteria

The Ms. Wheelchair America judging is based upon criteria established by the national committee of the Ms. Wheelchair America Program. The following excerpts were taken from official guidelines:

A. Accomplishments (40%)

- 1. Personal achievements/accomplishments since onset of disability only in the following areas:
 - a. *Academic
 - b. *Vocational
 - c. *Personal
- 2. Adjustment to disability.

B. Community Skills (40%)

- 1. Ability to deal with media, peers, civic groups, etc.
- 2. Public Relations skills.
- 3. Advocacy for persons with disabilities.
- 4. Self-confidence/motivation/initiative/creativity.

C. Self Perception/Projection (20%)

- 1. Poise, demeanor.
- 2. Appropriate attire, personal presentation.
- * Ms. Wheelchair America is not a beauty contest and this category is not taken as a license to choose the most attractive entrant. Instead, the items in this category are simply to express a desire to have a pleasing appearance capable of obtaining favorable responses from any audience before which Ms. Wheelchair America would appear.

Ms. Congeniality is chosen by the contestants for this year's pageant for her friendly and cheerful personality and her helpfulness to them during the program weekend.

Dawn Blodgett - Judge Coordinator

Dawn Blodgett, a former Ms. Wheelchair America (1994), currently lives in Costa Mesa, California. Dawn travels as a motivational speaker around the United States, challenging her audiences to "Face their fears and follow their passions." She is a full-time student with a major in Psychology and a minor in speech.

Debbie David - Judge

Debbie David is a Senior Analyst at American Airlines Corporate Headquarters Airport Services, overseeing airport operations issues for customers with disabilities. She assumed that post in 1994 after serving in a variety of airport and management positions with the airline since 1987. Ms. David's duties include the development of airport passenger service policies, procedures and training related to American Airlines services for customers with disabilities. Ms. David is administrator of the American Airlines Advisory Committee on Serving Customers with Disabilities with 13 national disability organizations actively participating. Ms. David, who is married and has one child, resides in Dallas/Ft. Worth, Texas.



Trish Farmer - Judge

Trish was appointed Executive Driector of the Governor's Committee for Employment of People with Disabilities in 1988. Prior to her appointment, she was the ASsistant Vice President of Finance and Audit for a health care corporation specializing in the treatment of head injuries and general rehabilitation. Her prior experience includes serving as Chief Financial Officer for a retail, wholesale corporation which consisted of seven corporations; Senior Accountant with an international "Big 8 Accounting firm"—Touche Ross and Senior Auditor for the Comptroller's Office of the State of Tennessee. She actively works and supports disability organizations in her spare time and is currently on the Board of Directors of the Volunteer State Rehabilitation Association and Executive Committee and Treasurer for the National Association of Governors' Committees.



Armando E. Rodriguez - Judge

Armando is the Director, Office of Diversity, Employment Service, U.S. Post Office of Personnel Management. As Director, Mr. Rodriguez provides leadership and guidance on diversity policy for the federal civilian work force. The Office of Diversity is responsible for the Federal Equal Opportunity Recruitment Program (FEORP) and the Disabled Veterans Affirmative Action Program (DVAAP). The Office of Diversity conducts statistical studies to determine the impact of employment programs and practices throughout the federal government and assists agencies develop strategic affirmative recruitment plans.

Mr. Rodriguez has vast experience in the private sector, where he has owned and operated his own business. He served clients in both the private and public sectors, in the areas of automated information systems, human resource planning and analyses, economic development and

organizational development. His public sector experience covers a range of managerial positions in various federal departments and agencies.

Mr. Rodriguez received an A.S. degree in criminal justice from Central Texas College, B.S. degree in sociology from West Texas State University, and M.A. degree in management and administration from Central Michigan University.



Dr. Sylvia Walker - Judge

Dr. Walker is a professor of Special Education in the School of Education and the Graduate School of Arts and Sciences at Howard University. She is Director of the Center for Disability and Socioeconomic Policy Studies and the Howard University Research and Training Center. Dr. Walker is a former Chairman of the Department of Psychoeducational Studies at Howard University. She received her Ed.D in Special Education/Administration and International Education from Teachers College, Columbia University. In addition to serving as a classroom teacher, administrator, teacher trainer, Dr. Walker has conducted research and training projects in the Caribbean, South America and Africa. Dr. Walker has taught at Hunter College, New York and the University of Cape Coast, Ghana, West Africa.

Dr. Walker has been appointed by President Clinton to serve as a Vice Chair of the President's Committee on Employment of People with Disabilities. She is the founder of the Walker-Thomas Fund for Social Advancement.

Debbie has been involved with numerous MDA telethons and volunteers much of her time for the MDA Association. She received ABC's Alabama's Best Citizen Award and attended a seminar by Mr. Justin Dart. Debbie has spoken to Kiwanis Clubs, Easter Seals, Alabama's Rehabilitation Associations Annual Convention, and many more. She has been involved in numerous parades, lun-

cheons, judged the Little Miss contest, and is a Daisy Girl Scout Leader. Debbie considers herself modest, helpful and organized.

California - Contestant #2 Patty Kolb

Patty lives in Carlsbad, California with her husband Gary and two sons. She uses a wheelchair due to bilateral above-the-knee amputation because of a bacterial infection. She has a degree in mathematics from the University of Redlands, and is now a stay-at-home mom and a professional volunteer. Patty is a Team Parent for numerous youth sports teams, and a reading tutor coordinator for 50 volunteer tutors at her sons's school. Her goal is to work diligently to change attitudinal barriers surrounding the disabled community, and to inspire others to overcome their diversities. She consistently works at making

areas accessible in her community. Patty was an honored speaker at the Tri-City Rehabilitation Luncheon and received the Outstanding Team Parent Award and the Key Volunteer Award for California Distinguished Schools. She considers herself passionate, respected and trustworthy.

Colorado - Contestant #3 Robin Ryerson

Robin lives in Lafayette, Colorado, with her husband Quentin. She uses a wheelchair due to Multiple Sclerosis and is currently attending The Naropa Institute in Boulder. Robin graduated from high school in Norwalk, Iowa, and obtained a MA in Chinese Civilization from the University of Iowa, a MS in Sociology and a BS in Family Services from Iowa State University. She also attended the Middlebury Chinese Language School in Middlebury, Vermont. Robin has interned at the Center for People with Disabilities in Boulder and was a co-therapist in group therapy for women with MS. She has been a teaching assis-

tant and a research assistant, including teaching English to university teachers preparing to study abroad. She is involved with the Colorado Therapeutic Riding Center, and was involved with a University of Colorado Class-Disabilities In America. Robin's goal is to finish her degree and become a psychotherapist and she describes herself as honest and witty.

Florida - Contestant #4 Ileana M. Cruz

Ileana lives in Miami, Florida with her parents. She uses a wheelchair due to Spinal Muscular Atrophy, which she has had since birth. She has a Master of Professional Accounting Degree from the University of Miami and a Bachelor of business Administration Degree from Florida International University. She is a Certified Public Accountant. Ileana feels she is capable of breaking through the barriers of age and certain minority groups due to the fact that she has been disabled her entire life, and speaks two languages fluently. She has been involved with MDA telethons since 1985 and has had numerous newspaper articles printed dealing with disability issues. She has received the Florida State Personal Achievement

Her goal is to become an anchorperson with the news, and also to win the title of MWA. She enjoys speaking with and educating children about persons with disabilities. She has received awards from the Iowa Rehabilitation Association and was 1986 Iowa State Handicapped Employee of the Year. She feels that she promotes awareness everyday in the number of her daily life. She considers herself patient, caring and determined.

Kentucky - Contestant #7 Terri Cecil-Ramsey

Terri lives in Louisville, Kentucky with her husband Forest and "the kids," (1 dog and 3 cats). She uses a wheelchair due to an automobile accident rendering her a T4-5 paraplegic. She graduated from the University of Louisville in 1995. She is currently the Assistant Manager of Carriage House Mobility Center. Her goal is to return to college and graduate school, and perhaps open her own business one day. Terri does extensive public speaking and is an On-Air personality for the area's third largest radio-station. She teaches fencing at the Louisville Fencing Center, and was a member of the 1996 Paralympic Fencing Team.

She received the Athlete of the Year for Fencing in 1996, from Wheelchair Sports USA. She is on the Board for the Center for Independent Living, and volunteers on the "Feisty Females" program. She claims to be a people fanatic and considers herself to be enthusiastic, supportive and empathetic.

Maryland - Contestant #8 Julie Hope Dennis

Julie lives in Glen Burnie, Maryland. She uses a wheelchair due to a beating in May, 1984. She has a BA in English/Politics, and is attending Anne Arundeel Community College taking Communications/Journalism and Paralegal for her AA degree. She is currently seeking employment in the field of law. Her goals are to pass the State Bar Exam, have a flouishing law practice, get married, and save enough money so her father can retire and then build two houses. She loves to take the time to speak with children who want to know about her disability, and other organizations and groups who request her to speak. She was selected the Most

Outstanding Student in 91-92 and made the Honors List. Julie was also a Chapbook Finalist in 1995, received the Presidential Award from Iiliad Press in 1996 and has had 10 literary works published in the past two years. She was accepted to work for the FBI in her senior year, but the day the call came she was dying from shock trauma. She survived a violent crime and has gone on to finish a double major and double minor plus a pre-law certification in just three years, while maintaining a B average. She describes herself as honest, persuasive and determined.

Zettie lives in Detroit, Michigan and uses a wheelchair due to a motor vehicle accident in 1983. She has a Business Degree from the Market Training Institute, and an Occupational Therapy Degree from the University of Detroit. She also received her Pastoral Counselor M.A. in 1995 from Ashland Theological Seminary. While at the University of Detroit she made the Dean's List. She is currently the Director of Counseling at Detroit Unity Temple. Her goal is to continue being an advocate for persons with disabilities, complete her Dell.D program, and open a healing center. She works with churches and hospitals

on accessibility issues, and works with individuals on specific concerns surrounding their disabilities, and has numerous awards to her credit including Who's Who of Women Executives and Star's Edge International Avatar Master. She considers herself dedicated, assertive and compassionate.

Mississippi - Contestant #10 Sonya Tharp

Sonya lives in Maben, Mississippi, and uses a wheelchair due to an accidental gunshot wound at the age of two years. The Story of JoeSam's Wheelchair Pins

JoeSam's Wheelchair pin is a replica of a pair of original sculptures. One was commissioned by the James Smith Neighborhood Center in Orlando, Florida, the other he donated to the Bayview-Hunter's Point Adult Day Health Center in San Francisco. Christmas in April, an organization dedicated to rehabilitation of public and private facilities in poor neighborhoods, was in the process of renovating the health center and approached JoeSam to add one of his colorful pieces to brighten the entrance area of the center. He visited the center and noticed right away that most of its users are in wheelchairs. JoeSam felt that the best way to bring some color and warmth to their day would be to create a sculpture of a happy person in a wheelchair chasing a bird. The director of the center promptly offered to let him use one of their discarded wheelchair wheels for his mixed media sculpture. The residents often go up to the sculpture and turn the wheel so that even a blind resident has been able to appreciate the sculpture.

Two years later, the University of Central Florida in Orlando, saw a picture of JoeSam's original wheelchair sculpture and requested a similar sculpture for their new Track and Field Arena. JoeSam, then designed a second sculpture of a boy playing ball in a wheelchair, reflecting the mobility of people in wheelchairs and their enjoyment of life. The Boy in Wheelchair pin is based on this sculpture.




Everyday Heroes

The Southern California Sunrise women's wheelchair basketball team consists mainly of students and alumni of Widney High School in Los Angeles, the nation's largest public school for the physically challenged. Since its inception in 1977, the Sunrise—one of 12 women's wheelchair basketball teams competing in the U.S.—has won the national championship four times and placed in the final four every year.

This year's squad blends the talent of experienced veterans with the enthusiasm of several new players, ranging in age from late teens to 30s. Five team members have represented the U.S. internationally. Jamie Danskin and Alma Torres, both current members of Team USA, participated in 1992's Paralympics in Barcelona. Many Sunrise players have been selected for individual recognitions including MVP and the National All-Tournament Team over the years.

To support their athletic endeavors, including tournament travel and equipment, the Sunrise depends solely on fund-raising events, and individual and corporate donations.
