
### Purpose And Goals Ms. Wheelchair America Program

The Ms. Wheelchair America Program is in no way a beauty contest. It is, instead, a competition to select the most accomplished articulate spokesperson for other persons with disabilities in the United States. The selected representative must be able to communicate both the needs and the accomplishments of her constituency to the general public, the business community and the lawmakers. She is charged with a continuing effort to educate the public regarding the dignity, productiveness and basic value of disabled people. She assumes the responsibility for the ongoing effort to eliminate the architectural and attitudinal barriers that prevent people with disabilities from assuming their rightful place in society.

As Ms. Wheelchair America, her duties are numerous. Each year she has the opportunity to travel, visiting advocacy groups, making public appearances and conducting television, radio and print interviews in the fulfillment of her major responsibilities. These include promoting awareness of the needs of disabled persons, creating an awareness for the need to eliminate architectural and attitudinal barriers and informing the able-bodied public of the achievements of physically disabled people across the nation.

We plan and conduct a four-day event to select our new Ms. Wheelchair America. The program is more than just the judging panel and one 'winner' is named. We schedule workshop sessions where we offer interesting topics of personal enhancement for the women, whether about grooming, communications and inter personal skill development, networking with community programs and other educational topics. We offer 'free time' to allow for information exchange between contestants to take place. Many new friendships are started from the program, as women validate the fact they are not the only one to use a wheelchair and experience some of the things they share with each other. The program offers an opportunity to enjoy five days at a luxurious hotel setting- here the contestants are really treated as special guests. The program is much more than just a healthy competition...it's an opportunity to see the potential within and to challenge personal growth.

The planning board for Ms. Wheelchair America is made up of volunteers from many different community organizations, businesses, private citizens, and previous title holders. There are few administrative costs to the program. All expenses for hosting the program, travel for Ms. Wheelchair America and expenses associated with he national Ms. Wheelchair America Program must be secured through various fundraising efforts, donations, etc. We welcome your assistance.

I'm not sure I can adequately sum up what a blessing the past year of my life has been and I don't even know where to begin in thanking all those who had a hand in making it possible...

My reign as Ms. Wheelchair America has been such a wonderful experience--one I will never forget and one for which I will always be grateful. I have traveled all across the country representing Americans with disabilities-being our voice, sharing our accomplishments as well as our dreams, and promising our commitment to helping to make the world a better place, one where diversity is celebrated! What an honor that has been for me!

I have spoken before medical professionals, school children, and everyone in between. It never ceases to amaze me what a tremendous teaching opportunity this is. However, what I didn't allow for back in August of last year was what an incredible learning experience this would be for me personally. I had no idea back then the impact this year would forever have on my life.

I will never forget the first time a parent hugged me and thanked me for spending time with his child. Nor will I forget seeing a beautiful little girl sit a bit taller in her chair and watching her eyes light up when talking about her someday participating in the pageant. I smile when I think of one little boy telling me that my picture would have a place of honor in this bedroom-on the wall between Shaquille O'Neal and Derek Jeter (is this great company or what?). Maybe best of all was having a 5th grader invite me to his school dance and then having him pay me the most perfect compliment.. "Terri, after 5 minutes with you I didn't even notice the chair."

While these experiences may seem like, and to a degree are, examples of my having an impact on someone else, I know in my heart that it was truly I who learned the most.

I have learned that a moment in time--a touch, a smile, a word of encouragement--can influence a life forever. I have learned to slow down, seek out those moments, and to savor them when they come. I have learned that we are all role models; that someone is always watching and that my words and actions may be the ones that a person chooses to emulate. I cherish that honor, I take it very seriously (but always with a smile!), and I pray daily to do it

I have learned that true beauty really does come from within. I've always said that but I'm not sure I really knew what it meant until this year. I have traveled extensively, crawled off airplanes at 8:00am to speak somewhere at 9:00am, and had more than my share of bad hair days but I have never felt prettier than when a child wraps his arms around my neck and tells me that he is glad he met me and that we are now friends. I know he won't remember if my hair was in place or if my makeup was flawless and he certainly won't care to what degree my legs work. What he will remember, what he will care about, is love. In a world that is often cold and cynical and focused on only the "perfect" people, I now know that that is enough.

To Quickie Manual Chairs-thanks for keeping me fencing; sports equals sanity, you know? To Pride Health Care, the makers of the best power chairs and scooters going... ### **Judging Criteria**

The Ms. Wheelchair America judging is based upon criteria established by the national committee of the Ms. Wheelchair America Program. The following excerpts were taken from official guidelines:

#### A. Accomplishments (40%)

- 1. Personal achievements/accomplishments since onset of disability only in the following areas:
  - A. \*Academic
  - B. \*Vocational
  - C. \*Personal
- 2. Adjustment to disability

#### B. Community Skills (40%)

- 1. Ability to deal with media, peers, civic groups, etc.
- 2. Public Relations skills.
- 3. Advocacy for persons with disabilities
- 4. Self-confidence/motivation/initiative/creativity.

#### C. Self Perception/Projection (20%)

- 1. Poise, demeanor
- 2. Appropriate attire, personal presentation.
- \* Ms. Wheelchair America is not a beauty contest and this category is not taken as a license to choose the most attractive entrant. Instead, the items in this category are simply to express a desire to have a pleasing appearance capable of Obtaining favorable responses from any audience before which Ms. Wheelchair America would appear.

Ms. Congeniality is chosen by the contestants for this year's pageant for her friendly and cheerful personality and her Helpfulness to them during the program weekend.

She majored in marketing and graduated from Texas Wesleyan University in 1987 with a B.B.A. Upon college graduation, she began her career with American Airlines, where her current position is Procedures Analyst in Advantage Customer Service. While at American Airlines she has served on many committees, but two of her favorites were as a charter member of the AMR diversity Council and the Consumer Relations Disability Council.

Other accomplishments include Vice President of the Handicapped Resource Association of Arlington, Texas, member of the Coalition of Texans with Disabilities and member of the Osteogenesis Imperfecta Foundation. Amy currently serves as vice president of the Ms. Wheelchair America Executive board, member of the Texas Planning Council for Developmental Disabilities (appointed by Governor Bush), and member of the United Methodist Church Disabilities Concerns Committee. 




#### Florida - Contestant #3 Lynn Naves

## Washington - Contestant #19 Lisa Doolittle


