History

In 1972 Dr. Philip K. Wood of Columbus, Ohio had devoted his career to treating and rehabilitating persons with functional impairments. During his practice, he became aware of the talents, capabilities, determination and courage of persons with disabilities. As a result, he established Ms. Wheelchair America as a forum for promoting the achievements and accomplishments of women who utilize wheelchairs for mobility, as well as the needs of all persons with mobility challenges.

The mission of Ms. Wheelchair America is to provide an opportunity for women of achievement to successfully educate about and advocate for the more than 54 million Americans living with disabilities. The Ms. Wheelchair America Program is in no way a traditional beauty contest.

Purpose and Goals

Each year the Ms. Wheelchair America Program holds a competition to select the most accomplished, articulate spokeswoman for people with disabilities. The titleholder must be able to communicate and educate the public, business community, and lawmakers regarding the dignity, productiveness and basic value of people with disabilities. Ms. Wheelchair America continues to eliminate the architectural and attitudinal barriers that prevent people with disabilities from assuming their rightful place in society.

Ms. Wheelchair America has numerous duties. During her reign she has the opportunity to travel, visit advocacy groups, make public appearances and conduct interviews. Ms. Wheelchair America promotes her chosen platform in a variety of settings. She serves as a positive role model for the next generation of Americans with disabilities inspiring them to leave their own legacy. Her commitment and personal example serves to further the mission of Ms. Wheelchair America.

The pageant is made up of a multitude of activities. This allows the judging panel time with the state titleholders, while enabling the competitors an opportunity share with each other and develop friendships. They become stronger advocates throughout the week because of the variety of the interesting workshops that strengthen them. They develop skills that heighten awareness on issues within the community, and open a dialogue between the women about their thoughts, ideas, values and experiences.

The Ms. Wheelchair America 501(c)3 non-profit is staffed and coordinated totally be volunteers from many different community organizations, businesses, private citizens, and previous titleholders. It is through the monetary and in-kind support of the many sponsors that the national titleholder is able to fulfill her duties throughout the year and travel across the country with her message of empowerment for the people with disabilities. The Ms. Wheelchair America Program is actively seeking sponsors and volunteers and would appreciate any support that is offered.

When I heard my name called as Ms. Wheelchair America 2011, I felt a mixture of overwhelming excitement and gratitude. These feelings have only increased throughout this amazing year.

This conference opened my eyes to the need to support people with disabilities through their complex tax returns, unexpected expenses and unique savings needs. A visit to Orlando, Florida for the National Federation of Women Legislators was a welcome the break from the chilly weather in November! This was four days of insightful speakers, heated policy debates, and bipartisan collaboration among women. The energy and brainpower in the room was inspiring. However, I also noticed who wasn't in the room: people who use wheelchairs. Like women, people with disabilities have been vastly

unrepresented in legislative bodies. But, I wouldn't be surprised if some of our Ms. Wheelchair America or state titleholders change that in the future!

During the last week of January, I traveled to South Dakota for Ski for Light, a week of skiing and fun for about a hundred people with various disabilities. The entire week was amazing. Not only did it allow me to meet some incredible people and experience skiing, but it also helped the way I think about the importance of fun and connecting with other people with disabilities. The organization was able to flawlessly adapt to and include people with disabilities (and the able-bodied volunteers) during both skiing and downtime. I cannot speak more highly of the organization, the dedicated peo-

In June, I acted as a Youth Mentor and gave several presentations at the weeklong NC Youth Leadership Forum. This forum brought together people with disabilities ages 16-28 to learn about self-advocacy, the government process, and disability history. It was amazing to see the students grow and learn throughout the week. I left with several new friends and role models!

events, I was honored to hold events at Bank of America, Progress Energy, the IZOD IndyCar Series, the Houston and New York Abilities Expos, Lowes Corporation, several elementary, high schools, and universities, sporting events, and conferences.

remarkable. 
Ms. Wheelchair Alabama Shannon Roberts




Ms. Wheelchair Massachusetts Megan Mamaty




Ms. Wheelchair Ohio Margaret Long

The Nicki Ard Achievement Award recipient is chosen by the judges and awarded to the woman who exemplifies the philosophy of Nicki Ard, which is to "always exhibit a positive attitude and be willing to serve others." The delegate will have made an outstanding contribution to the disability community through her talents, her efforts and example.

Outstanding Speech

The Outstanding Speech Award is chosen by those in attendance on Speech Night. Each individual attending receives one vote to cast for the contestant they feel delivered the most memorable speech of the evening.

People's Choice

The People's Choice Award is present to the person that gets the largest number of votes, which cost \$1.00 per vote. The funds raised will be used for the MWA 2011 travel fund. People's Choice votes can be purchased anytime during the week.

Congeniality Award

The Congeniality Award is chosen by the contestants. Each contestant casts one vote for the contestant they feel was the kindest, friendliest, most helpful and caring during the week.

Business Award

The Business Award is chosen by the various businesses that present workshops, attend events, or interact with the contestants. They will give this award to the contestant they feel was able to communicate on a variety of topics.

More on the Nicki Ard Award



Nicki Ard was Ms. Wheelchair America 2001 and passed away in 2002, about a month after crowning her successor. Nicki was born with a debilitating disease called Spinal Muscular Atrophy which resulted in her using a wheelchair. She also developed Scoliosis, as a result, she lost full function in her left lung. Although she was given a predicted life span of 13 years, she faced and conquered her physical challenges for almost 30 years. She began singing at the age of 6, established "the Music Ministry of Nicki Ard" in 1986, and released two albums "From Nicki, With Love" and "Walk With Me".

Nicki was also enjoyed writing poetry.

My Thoughts

I've seen times in my life when I was given only five seconds to say the right words, only to have them come out wrong or not at all.

Times when I've loved with every part of me and then lost that which I loved so much.

Times when I knew the odds were against me, but thought,

"Who created the odds anyway?"

Times when my heart was so full of grief that tears meant nothing.

They will remain forever a part of me, but I cannot bring them back and


make them over to be times of joy.

Head Judge—Susan Rotchy was Ms. Wheelchair California

2007 and currently resides in Northern California with her husband and two children. She was left paralyzed from an automobile accident 15 years ago. Since her accident Susan has become an activist for people with disabilities beginning with, having a voice at the community college she attended and with that voice enforcing the college to become ADA compliance. Realizing, she had an aptitude to bring the disability community and the able body community together from this experience she proceed straight to the capitol while completing her Bachelor's degree in Business Administration at Golden Gate University.

Susan wanted to move her paralyzed body again and realized that there was potential research being done for spinal cord injuries but there was no adequate funding for the scientists. In 2000 she helped pass the Roman Reed Spinal Cord Injury Research Act through her membership in Californians for Cures, which also took an active part in the passage of Proposition 71, the Stem Cell Research and Cures Act 2004. Additionally, she is one of the co-founders of Research for Cure, a 501(c) 3 nonprofit organization which raises money for neurological dis-

eases, which has raised over 500,000 dollars for the Reeve Irvine Research Center at UC Irvine. For her continuous work on raising monies for research she has been thanked by the late Christopher Reeves and California Governor Arnold Schwarzenegger.

Today, Susan is the Executive Director of Independent Living Resources of Solano and Contra Costa Counties and sits on the In Home Support Service advisory committee for Solano County and vice president of Research for Cure. She has played an instrumental role in advocating for people with disabilities and pushing for medical research.



Carles Daughtery is a native of North Little Rock, Arkansas. He earned his Bachelor of Arts degree in Sociology from Philander Smith College in Little Rock, and earned a Master's Degree in Public Administration in 2001 from Webster University in Jacksonville, Arkansas. He also graduated from the University of Arkansas Currents Leadership Institute in 2005. In addition to his education, Mr. Daughtery has an exemplary background in business and public relation. Before being appointed to his present position in August 2009, Mr. Daughtery served as the Interim Chief of Field Services. He previously served as District Manager for five years in the Vocational Rehabilitation Field Services Program covering North Little Rock, Conway, Russellville, and Lonoke field offices. He acted as head judge for the Ms. Wheelchair Arkansas twice and supported Ms. Wheelchair Arkansas.

Mr. Daughtery and his wife, Cynthia, have one son, Carl Jr. He plays a very active role as husband and father. As Chief of Field Services, he is committed to continuing his services and leadership to our state and its people with disabilities.



Stephanie Crenshaw was Ms. Wheelchair Georgia 2006. She was

selected as Ms. Congeniality at the national pageant in 2007. Stephanie has her Master's in Rehabilitation Counseling from Thomas University and has worked as Vocational Rehabilitation Counselor with Georgia Department of Labor. Stephanie uses a wheelchair due to progressive neuromuscular disease. She has participated in several road races and finished 2nd in Walt Disney World's half marathon in 2006.

Stephanie lives in Georgia with her daughter, Kaitlyn.

Judges



George Flores is X-Rock & Roller turned Harp Technician for Harpist all over the world. He was thrown from his motorcycle on September 11, 2004. He hung on to life in four feet of wetland grass for over twelve hours. Two men searching for scrap metal on the side of the road finally rescued him. George was taken to a hospital in the west suburb of Chicago where his disabled journey began. After many surgeries and complications George laid bed ridden for over two and a half years. Never giving up the dream to once again touch the top of the six-foot instruments he loves. George found the answer in technology and the form of a standing wheelchair. Working hard to reclaim his health & life in 2008 George became the first person in history to professionally service the six-foot instrument with a spinal cord injury. Today, George still works with the Harps he loves and just

finished building and regulating a Harp for the N.S.C.I.A. to be auction off to raise money to support people with spinal cord injuries.

George is also a huge advocate for people with disabilities. Using the knowledge he gained over the past seven years to help reassure that people would not have to suffer or struggle as he did.



Richard Wolter's serves as the President of the Kate and Richard Wolter's Foundation. Founded in 1997 by Kate and her late husband, Richard, this private foundation makes grants to non-profit organizations with an emphasis in the arts, education, human services and people with disabilities. Kate is also a member of the Board of Directors of Steelcase Inc., chair of its Nominating and Corporate Governance Committee and chair of the Steelcase Foundation, an endowed corporate foundation of Steelcase Inc. Steelcase Inc., the global leader in the office furniture industry, delivers a better work experience to its customers by providing products, services and insights into the ways people work. Its portfolio includes architecture, furniture and technology products. Kate was appointed to the Board of Directors in September 2001. She was appointed chair of the Steelcase Foundation Board upon her leaving the post of executive director of the Steelcase Foundation in October 1996.

Kate was appointed by President Bill Clinton to the National Council on Disability in 1994 and was reconfirmed by the U.S. Senate in 1996 and served until 2003. For eight of her nine years on the council, she served as its vice chair. Kate currently serves as a board member for a number of organizations, including Michigan Protection and Advocacy Service and the Grand Rapids Symphony. She also serves as a member of the board of the Mary and Robert Pew Public Education Fund, a foundation established by her parents that addresses public education in Palm Beach County, Florida. She serves as co-chair of First Steps Early Childhood Commission and was appointed by Gov. Granholm to an eight-year term as a member of the Board of Grand Valley State University in 2004. Kate holds a Masters Degree in Social Work from Michigan State University and a bachelor of arts degree from Aquinas College.

Judging

The contestants will have three private judging sessions with the panel of judges during the week. On Friday evening, each state titleholder will present a two minute speech. The speeches are also judged. During the Saturday Crowning Gala the five contestants with the highest scores will give their speech again and answer two on stage questions. After the scores are tallied the runner-ups will be announced followed by the new Ms. Wheelchair America 2011.

These workshops are designed to provide information on topics that will help each state titleholder develop various skills that are need to be an effective advocate, while building relationships with each other.
