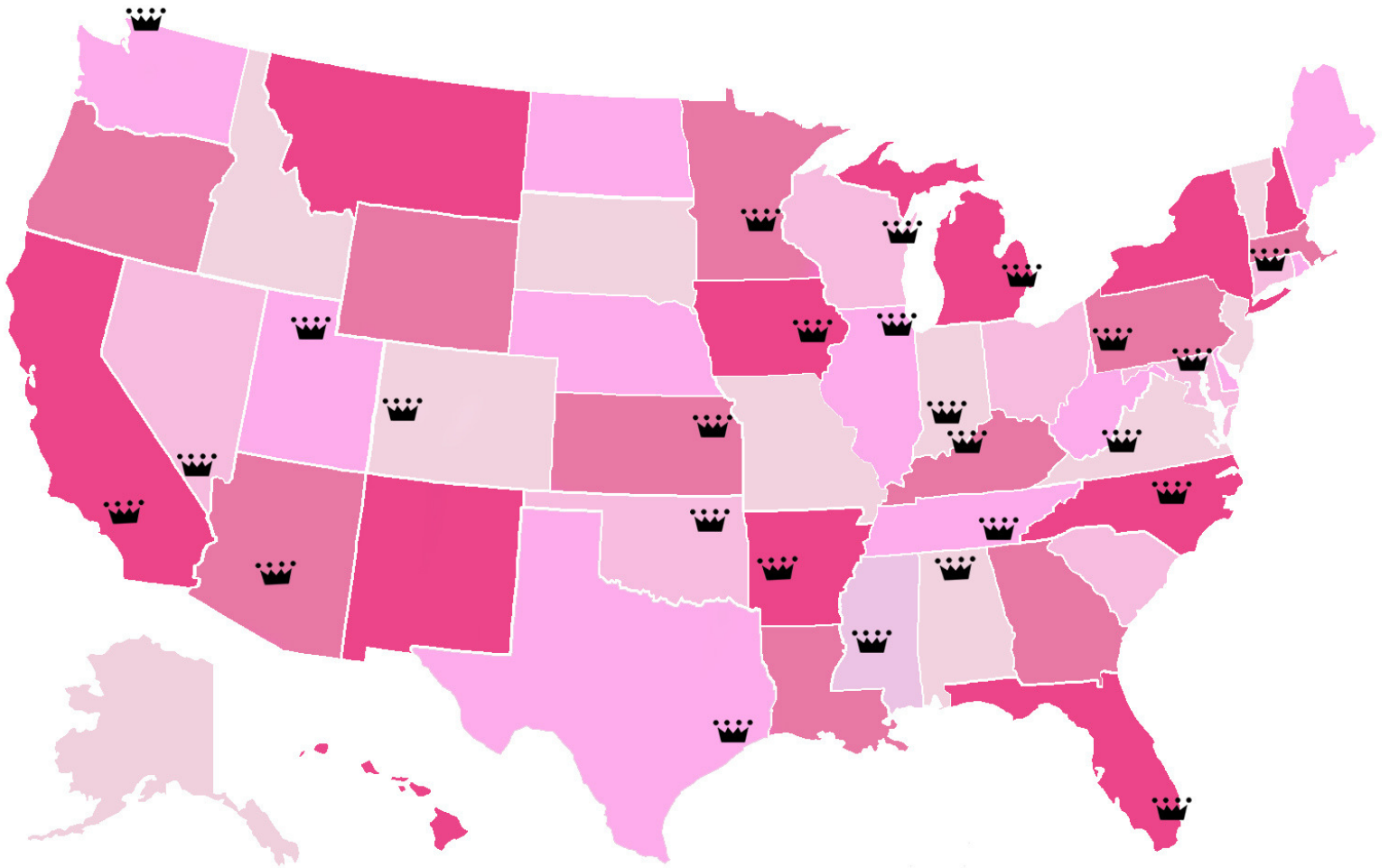

History

In 1972 Dr. Phillip K. Wood of Columbus, Ohio had devoted his career to treating and rehabilitating persons with functional impairments. During his practice, he became aware of the talents, capabilities, determination, and courage of persons with disabilities. As a result, he established Ms. Wheelchair America as a forum for promoting the achievements and accomplishments of women who utilize wheelchairs for mobility, as well as the needs of all persons with mobility challenges.

The mission of Ms. Wheelchair America is to provide an opportunity of achievement for women who happen to be wheelchair users to successfully educate and advocate for the more than 56 million Americans living with disabilities. The Ms. Wheelchair America Program is in no way a traditional beauty contest.

Purpose and Goals

Each year the Ms. Wheelchair America Program holds a competition to select the most accomplished, articulate spokeswoman for people with disabilities. The titleholder must be able to communicate and educate the public, business community, and lawmakers regarding the dignity, productiveness, and basic value of people with disabilities. Ms. Wheelchair America continues to eliminate the architectural and attitudinal barriers that prevent people with disabilities from assuming their rightful place in society.

Ms. Wheelchair America has numerous duties. During her reign she has the opportunity to travel, visit advocacy groups, make public appearances, and conduct interviews. Ms. Wheelchair America promotes her chosen platform in a variety of settings. She serves as a positive role model for the next generation of Americans with disabilities, inspiring them to leave their own legacy. Her commitment and personal example serves to further the mission of Ms. Wheelchair America.

This pageant is made up of a multitude of activities. These activities allow the judging panel time with the state titleholders, while enabling the competitors an opportunity to share with each other and develop friendships. They become stronger advocates throughout the week because of the variety of interesting workshops that strengthen them. The workshops develop skills that heighten awareness on issues within the community, and are designed to open a dialogue between the women about their thoughts, ideas, values, and experiences.

Ms. Wheelchair America, a 501(c)3 non-profit organization, is staffed and coordinated solely by volunteers from many different community organizations, businesses, private citizens, and previous titleholders. It is through the monetary and in-kind support of many sponsors that the national titleholder is able to fulfill her duties throughout the year and travel across the country with her message of empowerment for people with disabilities. The Ms. Wheelchair America Program is actively seeking volunteers and sponsors and would appreciate any support that is offered.

A farewell message from Eliza McIntosh-Stauffer, Ms. Wheelchair America 2017

I grew up with a disability, but I never knew it was supposed to stop or define me. I knew it got me stares from adults, and curiosity from kids. I knew people noticed me from a distance, or the second I got into the room. When I was younger, that really bothered me. I wanted to be seen first, instead of my wheelchair. My mother called me out on it. She said it was silly to be depressed about something that would happen my whole life. She said I had a choice. I could either let it stop me, or not. I could hate the attention my wheelchair brought, or I could use it. There was no guidebook for how to do it, no magical moment where I was suddenly totally comfortable and knew exactly what to say. That's not how activism works. Being an activist isn't a job you sign up for. It's a decision you make every single day. It's deciding to use the opportunities that come your way. It's about choosing to speak up and speak out about a passion. It's about using your differences to better the world.

Entering Ms Wheelchair Utah was a completely new experience for me. I'd never even considered being in a pageant. I grew up playing chess and sports, not playing with makeup or dresses. All I knew about was the frou frou stuff I'd seen in movies and that felt nothing like me. What I was interested in, however, was politics and advocacy. In 2015, I was chosen to be on a Zoos, Arts and Parks Committee. I got to work with five mayors and many State department heads on approving new facilities and projects for the county. I was the youngest on the Committee by over two decades and yet, because of my disability, I had an opportunity for leadership. Because of my life experience as a wheelchair user, and basic knowledge of ADA regulations, I was suddenly, and unexpectedly a voice of authority in government proceedings. It was bizarre and exhilarating. I was an advocate, even though I never intended to be. I was an advocate because of my differences. I was an advocate, *because I showed up*. This was a new



concept to me, a new opportunity. So I capitalized on it. I became a delegate in my state, so I'd have an opportunity to talk to politicians about better accessibility. I signed up for Ms. Wheelchair Utah, because I figured I might meet others who were doing the same thing. Even if not, I figured that if I won, maybe I could get a few more doors to open for the issues I cared most about. I thought I knew what I was signing up for. I didn't.

I had no idea the opportunities that would come my way once I gave myself the excuse to commit myself to advocacy. I had no idea about the sisterhood that I was joining, or the power there was behind them.

I'm just a 22-year-old college girl. I have no formal training in disability advocacy. The only advocacy network I have is the one I gained by going to the National Pageant. I traveled to 15 states, and three countries during my reign, and stayed on people's couches, spare beds or donated hotel rooms every time except for once. Most of the time, the first time I met them was when they picked me up from the airport. We didn't know each other, but we were bonded by the same drive for advocacy and the same dreams, and that was enough. The advocates I met in all of the states I visited were passionate people, using their differences and strengths to make the world a better place, with or without a crown.

This pageant is not about who wins. It's about coming together as advocates and working as a sisterhood to see real progress in our states. To pool resources and think tank our way to solving problems. Only one woman wheels away with a crown, but everyone receives training on how to advocate. This pageant will be what you make it. You can use the opportunities that come with it... or not.

Awards

Ms. Wheelchair America 2018

Ms. Wheelchair America 2018 is chosen by the judging panel. The contestant that earns the highest total score during the judging sessions will become Ms. Wheelchair America 2018.

Lifetime Achievement Award

The Lifetime Achievement Award is chosen by the judges and given to the contestant that they believe has made the largest contribution and significant impact for people with disabilities.

Nicki Ard Achievement Award

The Nicki Ard Achievement Award recipient is chosen by the judges and awarded to the woman who exemplifies the philosophy of Nicki Ard, which is to “always exhibit a positive attitude and be willing to serve others.” The delegate receiving this award will have made an outstanding contribution to the disability community through her talents, her efforts, and her example.

The Outstanding Speech Award

The Outstanding Speech Award is chosen by those in attendance on speech night. Each individual attending receives one vote to cast for the contestant that feel delivered the most memorable speech of the evening.

The People's Choice Award

The People's Choice Award is presented to the contestant who receives the most votes. Votes cost \$1.00 each and can be purchased during the week of the pageant. Forty percent of the funds raised will be distributed to the award recipient's Ms. Wheelchair State Program while the remaining funds will go into a Ms. Wheelchair America 2018 Companion Travel Fund.

The Congeniality Award

The Congeniality Award is chosen by the contestants. Each contestant cast one vote for the person that they feel was kindest, friendliest, most helpful, and caring throughout the week.

The Business Award

The Business Award is chosen by the various businesses that present workshops, attend events, or interact with the contestants. This award will be given to the contestant that the businesses feel was able to communicate on a variety of topics.

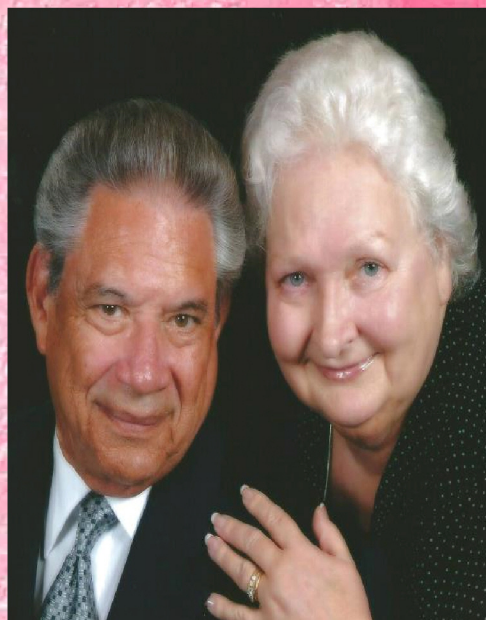

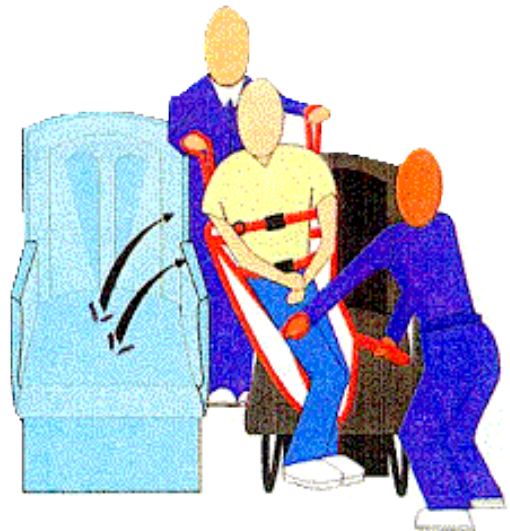

When my wife and I took our daughter, who was three at the time, to see Disney on Ice several years ago, I felt the greatest sense of professional fulfillment that I'd ever experienced. Seated across the front row of the arena were several children in wheelchairs, each right beside parents and friends. They were laughing and having the best time. Clearly, it was a very special experience for the children and their families – and I had played a small part in making it happen.

Had they visited the arena a few months before that show, they would not have had lower level accessible seating. Instead, they would have had

seats under stairs leading to the upper level, no clear view of the performance, and limited seating for family and friends. They would have had difficulty locating accessible parking, getting into the arena, and even more difficulty using the restrooms. Because some of my clients with disabilities had previously decided to enforce their civil rights, those children and their families were able to enjoy an experience without the barriers they so often face; an experience that countless people with disabilities have been able to enjoy since.

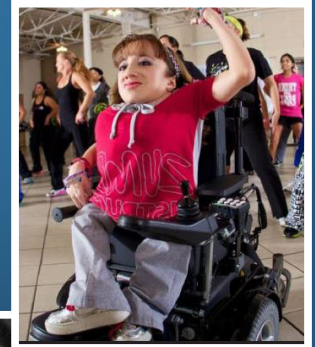
